### **Changes to official COVID-19 guidance and advice**

The School will contact the DfE Helpline (0800 046 8687) as required for support on what action to take when responding to a positive case or possible outbreak.

### **Vulnerable & extremely vulnerable staff or pupils with pre-existing health conditions**

Pregnant women are categorised as 'clinically vulnerable' as a precautionary measure and are advised to follow [the Government guidance Coronavirus \(COVID-19\): advice for pregnant employees](#)

### **Staff, pupils & household members who are asymptomatic**

- School is actively engaging with the asymptomatic testing programme, promoting its benefits to staff, pupils and parents/carers;
- A separate risk assessment is in place for the LFD [on-site testing programme](#) and [home testing programme](#);
- The asymptomatic testing programme does not replace the current testing policy for those with symptoms. Anyone with symptoms (even if they recently had a negative LFD test result), will be advised to self-isolate immediately according to government guidelines and [book a test](#);
- On site LFD testing is available for small number of pupils who are unable or unwilling to test themselves at home.

### **Staff, pupils & household members test positive for COVID-19**

- Based on the outcome from the rapid risk assessment, School will send home those people who have been in close contact with the person who has tested positive, advising them to self-isolate for 10 days since they were last in close contact with that person when they were infectious. Close contact means:
  - face to face contact including being coughed on or having a face to face conversation within one metre;
  - being within 1 metre for 1 minute or longer without face to face contact;
  - being within 2 metres of someone for more than 15 minutes (either as a one-off contact, or added up together over one day);
  - travelling in a small vehicle, i.e. a car, with an infected person;

### **Transmission of Covid-19 due to lack of consultation on safe working practices and provision of information & instruction on safe ways of working.**

- Rapid testing remains a vital part of our plan to suppress this virus. Schools should follow the guidance set out for their settings: [Primary schools asymptomatic testing](#)
- Staff in primary schools will continue to test with LFDs twice a week at home, as per existing guidance on [Testing for staff in Primary schools](#)
- Primary age pupils will not be tested with LFDs.

### **Transmission of Covid-19 through airborne particles due to close proximity to others**

- Masks and face coverings must be worn by staff and adult visitors in situations where social distancing between adults is not possible, this includes all areas outside their classroom including: communal areas and when moving around school and when on the school playground.
- In addition, staff and pupils are required to wear face coverings in classrooms and other teaching environments unless social distancing can be maintained. This does not apply in situations where wearing a face covering would impact on the ability to take part in exercise or strenuous activity or to those who are exempt from wearing a face covering;
- Whatever the size of the group, children should be kept apart from other groups where possible. Encourage pupils to keep their distance within groups. Different classes should not share rooms and social spaces.
- All teachers and other staff can operate across different classes and year groups to facilitate the delivery of the timetable and specialist provision. Where staff need to move between groups, they should try and keep their distance from pupils and other staff as much as they can, ideally 2 metres from other adults. Try to minimise the number of interactions or changes wherever possible.

#### Transmission of Covid-19 through airborne particles due to inadequate ventilation


To balance the need for increased ventilation while maintaining a comfortable temperature some flexibility on suitable indoor clothing is permitted, furniture is arranged where possible to avoid direct draughts and high level windows are opened in colder weather in preference to low level to reduce draughts;

#### Transmission of Covid-19 through airborne particles due to singing, chanting, playing wind or brass instruments or shouting.

- Performances to a live audience are not permitted;

They do not need to go home unless they display the symptoms themselves or are advised to do so by NHS Test and Trace, the school or Local Health Protection Team;</li> <li>• If a pupil displays symptoms their parent/carer will be required to take them home. Where this is not immediately possible, the pupil will be placed in a separate room, the SWAN Room, until they can be collected, whilst being mindful of the individual pupils' needs;</li> <li>• Ideally, a window will be opened in the room for increased ventilation;</li> <li>• If it is not possible to isolate the pupil e.g. if it causes them undue distress or they need to remain under adult observation, an assessment will be carried out to see whether it is sufficient to move them to an area which is at least 2 metres away from others;</li> </ul>
